

*Terms and Conditions:

- *1. You must first become a customer by purchasing a SARONI product that can be marketed by WHO.
- 2. After experiencing the benefits of the product, if you choose to pursue it as a business, you should introduce it to others and convert them into customers.
- 3. If someone you introduce wants to start the business, they must do the same tasks as you.
- 4. Your business will only start once they become a distributor.
- 5. This is a one-year contract. To continue with the same distributor number next year, you must pay an additional ₹10,000 one month in advance.
- 6. 5% of your weekly earnings will be deducted as an admin fee.
- 7. A 5% TDS (Tax Deducted at Source) will also be deducted.
- 8. You must make a mandatory repurchase of ₹1599/- every month.
- 9. Your ID must be duplicated to receive payment.
- 10. Payments will be released only to those who make repurchases from the following month after joining.
- 11. Every Wednesday is the cut-off day for payments, which will be released on Saturday to those who qualify.
- 12. Rewards and awards will be calculated and distributed to beneficiaries every three months.
- 13. If any distributor is found to be recruiting our distributors while working for another company, their business will be terminated immediately.
- 14. The company will cancel the rights of any distributor found to be operating illegally, without discrimination.
- 15. Since the company does not take even five paise for distribution rights, you cannot file any legal case against the company.
- 16. You can only expect the commission that has been set for the work you do after it has been communicated to you.
- 17. If it is not provided, you must first negotiate with the company, understand the reasons, and get a letter for the same. If you are still dissatisfied, you can file legal proceedings only in the courts located at Chennai Tourist Station.
- 18. You can obtain an annual certificate for the TDS you have paid.
- 19. The company will not accept claims of money paid without a receipt. The person to whom you paid will be responsible.
- 20. If you damage the reputation of the company, the company will revoke your distributor rights and may also take legal action.
- 21. Any distributor found defaming the company will have their distribution rights canceled.
- 22. The cost of courier services for any product sent by the company will be borne by you.
- 23. If a product arrives damaged, you can return it to the company within 15 days without breaking the seal on the bottle, and receive a replacement. The company will cover the courier cost for this.
- 24. The administration works only from 10 AM to 6 PM. During this time, any of your queries will be answered.
- 25. You must decide which products to provide and which not to, based on the diseases of the customer. The company will not be responsible for any mistakes you make.
- 26. The company is always ready to arrange a consultation with a doctor over the phone if needed.
- 27. As per the company's conditions, you can start a pharma business by paying the required amount as a licensing fee.
- 28. You are not allowed to sell any products other than those licensed by our company.
- 29. The administration is not responsible for disputes within your group or for personal likes and dislikes.
- 30. All the business tools you need will be available on the website. You must download and print them yourself, as the company cannot provide printed versions.
